

## MEMORANDUM OF UNDERSTANDING (MoU)

This MoU is made on this day of October 28, 2025 by and between:

Chhattisgarh Society for Information Technology formally registered under the Chhattisgarh, India Society Registration Act No.44, 1973 on 17th April 2025 (Here after referred as CGSIT- which term shall be deemed to mean and include its successors and assigns).

AND

The Scholars Gate (A non-profit organization register under MSME, Govt. of India having its corporate office in Tiruvannamalai, Tamil Nadu, India. (Here after referred as SG, which term shall be deemed to mean and include its successors and assigns.)

WHEEAS

CGSIT and SG have agreed on following points:

1. CGSIT shall organize workshops and other activities in association with SG as mutually decided by the two parties from time to time.
2. In all promotional materials, including participant certificates, the name and official logo of CGSIT shall appear first.
3. E-certificates shall be issued by SG, and all promotional materials related to the event shall also be prepared and provided by SG.
4. The registration fee for a three-day event, with two hours of sessions per day, shall be Rs. 200 per participant. The fee shall be collected by SG, and 10% of the total amount collected shall be transferred to CGSIT during the event.
5. In the case of events of longer duration (either more days or more hours), a proportionate registration fee shall be mutually decided by both parties.
6. A total of five CGSIT members shall be entitled to free registration for the event.
7. Mr. H. S. Tondey, Vice President of CGSIT, shall represent CGSIT. He shall have final authority on behalf of CGSIT, and all his financial and non-financial decisions shall be binding on CGSIT
8. Mr. Sathishkumar Sankar, Managing Director of SG, shall represent SG. He shall have final authority on behalf of SG, and all his financial and non-financial decisions shall be binding on SG.

Based on this, two parties wish to enter into MoU .

**Now it is agreed between the parties as follows:**

CGSIT and SG will jointly work out the terms and conditions to be offered to carry out all other activities. This is a nonexclusive relationship for the parties.

**Validity of agreement**

This MoU will be valid for one year only.

No party shall assume or shall be responsible for taxes, assessments, accounts payable, commitments, agreements, understandings, claims, debts, demands, obligations and liabilities of the other party: caused by, arising out of, or resulting from, any act or omission of their officers, employees, agents or independent contractors.

### Intellectual Property Rights

As a part of this project, SG and CGSIT will protect each other's Intellectual Property Rights.

### Confidentiality

SG and CGSIT shall keep in confidence any information obtained under this MoU and shall not divulge the same to any third party without the prior written consent of the other party, unless such information is in the public domain and already in the possession of the receiving party.

The Parties confirm their agreement to the above and have executed this MoU through their authorized signatories on the date shown below.
